### Violations Comments

#### Violation #10. Food container

Milk stored on floor in walk-in cooler. Need to install shelves to maintain 6" clearance for cleaning.

CODE REFERENCE: Storage Containers. 64E-11.004(13)(14). Food storage containers shall be clean, covered, and marked with their contents.

Refrigerated, ready-to-eat, potentially hazardous food prepared in the facility, must be marked with date of preparation, if held greater than 24 hours.

Food must be stored six inches above the floor.

#### Violation #27. Design and fabrication

Repaint flaking paint of prep table. (See photos)

Remove old non-useable warmer SCPS # 00003644, only equipment that is in working order needs to remain in kitchens.

CODE REFERENCE: Designed. 64E-11.006(2). All equipment will be the proper design and fabrication.

#### Violation #37. Garbage disposal

Dumpster needs to be on nonabsorbent material, currently it is on the grass.

Due to dumpster proximity to the kitchen, maintain all garbage and recyclables inside the containers. Currently, trash and recycling is strewn about the area. Vectors can use this as a food source and find their way into the kitchen.

CODE REFERENCE: Garbage. 64E-11.007(6). Garbage will be disposed of to prevent vector harborage. Garbage containers will be leak proof. Outside storage will be on top of a smooth nonabsorbent material.
